<b>SUB-CONTRACTORS:</b>	Are required to submit the <b>application</b> and pay <b>\$50 annual registration fee</b> .
<b>ELECTRICAL CONTRACTORS:</b>	Are required to submit the <b>application</b> , pay <b>\$50 annual registration fee</b> , <b>CERTIFICATE OF INSURANCE</b> for <b>General Liability</b> in the amount of <b>\$1,000,000</b> listing the <b>Village of Plainfield</b> as <b>certificate holder</b> and a copy of current <b>Illinois electrical license where electric test was taken</b> .
<b>PLUMBING and IRRIGATION CONTRACTORS:</b>	Are required to submit the <b>application</b> , <b>NO FEE</b> , and provide a copy of the <b>Illinois Health Certificate</b> in the <b>business name</b> and the <b>Owner's Journeyman's card</b> or <b>Illinois Health Certificate</b> and/or <b>Irrigation certificate</b> .
<b>ROOFING/SIDING CONTRACTORS:</b>	All roofing & siding contractors who are <b>acting as Generals</b> , are required to submit the <b>application</b> , pay <b>\$50 annual registration fee</b> , provide a <b>SIGNED, SURETY BOND</b> in the amount of <b>\$10,000</b> and <b>CERTIFICATE OF INSURANCE</b> for <b>General Liability</b> in the amount of <b>\$1,000,000</b> listing the <b>Village of Plainfield</b> as <b>certificate holder</b> . <b>Roofers</b> must provide a current copy of <b>State of Illinois Roofing License</b> .

All contractors must submit an updated Contractor registration form yearly.
